

MAT FINALS ON TONIGHT

With championships assured in two classes, Central Y wrestlers won six semi-final bouts in the city championship meet last night at the Central Y. The Columbus Club carried off four semi-final verdicts and the Aljo Club two. The other four were byes.

Mike Bulavinez and Maley, Central Y, won both of the bouts in the 175-pound class for the Central Y while Payne and Houla did the same in the 118-pound division. Other Central contestants to win were Friedman in the 126, Geiger in the 145.

Columbus Club standard bearers to capture verdicts were D'Ambrosia in the 135, Howie Reynolds in the 145, Al Brunetti in the 155, and Gene DePrez in the heavy-weight division. Aljo Club semi-final winners were Art Bott in the 126, and Rickless in the 135.

Howie Reynolds and Granata of the Aljo Club put up the long distance match of the night with the Civic Center star winning after two extra periods. Only two falls were scored, both in the preliminary round. D'Ambrosia scored one and Geiger the other.
