#### **SUMMER IN THE HOSPITAL**

I started feeling sick shortly after the 2003-2004 wrestling season, if I recall correctly. I was getting "dry heaves" every day after I got up in the morning, and sometimes, not-so-dry heaves.

Something even more serious developed on May 8, 2004, as a fistula ("canal") developed from my colon to my bladder, causing "gas" and waste matter to contaminate my bladder.

Further complications came on May 27 when I woke up with extremely blurred vision. I saw my eye doctor, who sent me to a neurological specialist. Their diagnosis was that I was In danger of going permanently blind at any moment! I had to drive to Brighton and back after my pupils had been dilated several times. I prayed a lot and was thankful to get home safely!

By June 3 my doctors were convinced I had prostate cancer.

Thankfully, on June 8 I felt good enough to go hot air ballooning from Red Creek, NY, with Webster Thomas wrestlers Kevin Sackett and Andrew Sheldon. Three days later Penfield varsity wrestling coach John Leone and Webster Thomas varsity coach Neil Cook stopped by to see how I was feeling.

I went hot air ballooning with Webster Thomas wrestlers Eric Snow and Robert Eskander on June 21.

Throughout this ordeal, I had a lot of labwork and tests. By far the most painful was on June 28 when I had a cystogram at Rochester General Hospital. That pain was the most I have ever felt in my life! Ironically, the cystogram turned out to be unnecessary, but another test that same day, a CT scan, revealed that I would need surgery on my colon.

I experienced severe diarrhea and vomiting on July 1 and my physical pain was beginning to increase noticeably. I had a colonoscopy on July 15.

July 16 I underwent major surgery at Rochester General Hospital. What was supposed to take two to three hours turned out to be much more complex, lasting about four hours. I lost a lot of blood and, according to my surgeon, I almost died on the operating table. When I awoke in my hospital room later, I was surrounded by nurses and med techs. My blood pressure was dangerously low, 60/40, but the kind and dedicated hospital staff "coached" me into getting it up to a safer level.

The next day Steve Fox, father of former Webster Schroeder wrestlers Randy, Chris, and Pete Fox, visited me in my room at Rochester General Hospital. He visited me many times during my two hospital stays during the summer, and also helped my brother Douglas in my absence at home.

Mark Krieger, father of former Webster Schroeder matman Andrew Krieger, was among my visitors on July 18 and visited several times after that, too. He was my top "Jeopardy" opponent when we played off the TV, cheering on Ken Jennings!

The funniest thing that happened during my hospital stays was later that evening when Webster Schroeder wrestler Torsten Gillespie, his parents, and his sister came to see me. I was "wired up" with a catheter (painful), oxygen, and IV tubes. Before the Gillespies came into my room, I heard Mr. Gillespie say outside my door, "Torsten, this time don't pull all the tubes out!"

I had a lot of Webster wrestling visitors on July 20, including Webster Thomas matman Tim Pilosi and his mom, Tom and Mary Giffi (parents of former Webster Schroeder matmen Jason and Justin Giffi) and Carl and Leslie Ziegler (parents of former WS wrestlers Eric and Rob Ziegler).

The next day my hospital visitors included Eric and Rob Ziegler, WS matman Danny Morreale, Larry DeVries (father of former WS wrestler Larry DeVries), and Gene and Sue Ziegler (parents of former WS matman Jim Ziegler).

Former Edison Tech, Monroe Community College and Ithaca College wrestler Mike Cronmiller stopped by on July 22, as did Jim Ziegler and his wife Kristin.

I came home from Rochester General Hospital on July 23, weak, but glad to be home. Steve Fox and his wife stopped at my house to visit me. Former Spencerport wrestler Lance Mitchel phoned me from military duty in Iraq and former WS matman Nick Smith called me from Georgia.

Webster Thomas grappler Eric Snow stopped by on July 24. Former WS wrestler Andrew Krieger visited me on August 3.

During the time I was home from the hospital, I was getting progressively weaker and there was a great deal of foul smelling drainage from my surgery and incision sites. When I went to see my surgeon on August 4, he readmitted me to Rochester General Hospital, this time with a life threatening abcess. I would be in the hospital this time until August 23.

Among the wrestling community people who visited me during this second, longer stay—not including some of those previously mentioned—were Jack and Margie Richardson (parents of former WS legend Chris Richardson), former WS matman Chris Rosini and his family, The Incredible Trio (WS matmen Torsten Gillespie, Dennis Costanza, and Mario Suchodolski), WS matmen Gregor Gillespie and Danny Morreale, Scott and Alice Winter (former WS matman Dave Winter's parents), Chris Richardson, WS manager Chelsea, ex-WS matmen Larry Devries and Chris Fox, and former Spry modified coach Steve Lysenko. In the hospital, I ran into Spencerport wrestler Bryan Bourne and his parents.

One time a total stranger walked in my room and said, "HI, I'm Jerenny." I must have watched too many *Touched by An Angel* episodes, because I thought for a minute that maybe he was an angel. He turned out to be a friend of Torsten's. Torsten and Gregor came in my room shortly afterward, but their trick worked!

I was discharged from RGH the second time on August 23.

Dave Winter stopped over at my house after I got home. The next day I had visiting nurse services coming to my home, and my main nurse was the mother of former WS matman Brendan Stevenson. Small world!

WS coach Dean Salvaggio and one of his sons, Austin, stopped by on August 26. Later that evening I collapsed while answering the doorbell and ended up spending several hours back in the hospital.

The next day Eric Snow came to my house and I passed out when I answered the door, but this time I didn't have to return to the hospital at least.

WT coach Neil Cook and Titan matman Alex Litto visited me on August 31, bringing me a new 27 inch TV and stand as gifts from the Webster Thomas team. This is definitely the best TV I've ever had! Thank you, Titans!

I returned to preaching at Resurrection Bible Church on September 19 and returned to my other job at the Shire at Culverton Adult Home on September 20.

I'm writing this on October 30. I'm still a little weak and dizzy at times, but life is good. I'm looking forward to the 2004-2005 wrestling season.

I didn't write all of this to bore anyone with the personal details of my life, but rather to show how many wonderful friends from wrestling ministered to me during my prolonged illness. I will always be grateful to God for His mercy and to these friends and many others for encouraging me in my recovery.

My church family was also extremely supportive during this time, as well as my brother, cousins, and many other friends, including a number from the Shire at Culverton.

I really miss the hospital staff; they were outstanding. Nancy, Sue, Antonio, Shalom, Darren, Theresa, Chia, Anne, and so very many more that I can't name them ali. I will always be in their debt. It amazed me how much they really cared about me. In addition to being skilled health care professionals, I saw them as being genuine friends!




