Seeding: Blind Draw (We will attempt to separate wrestlers' from the same club and town – first round only)
Weigh Ins: Sunday, March 16th, 2008. 7-9am. No weight allowance. If you don't make weight, you don't wrestle (no exceptions). Special consideration for wrestlers also wrestling at the Brute Empire Nationals on Saturday March 15th, 2008: The Brute Empire Nationals weigh-in will be honored for this tournament.
